

INDONESIAN VISA INFORMATION

FREE VISA FOR SHORT VISIT

Based on Presidential Regulation of the Republic of Indonesia No. 16/ 2008 on the Second Changing of Presidential Decision No. 18/ 2003, there are 11 countries which accepted by Free Visa for Short Visit (BVKS). Citizens from the following countries are allowed to stay in Indonesia of up to 30 days without visa.

Visitors should be in possession of valid passport of 6 months validity and a return or an onwards journey ticket at the time of arrival and this visa is not for employment and is not extendable:

VISA ON ARRIVAL

In accordance with the Regulation of Ministry of Law and Human Rights of the Republic of Indonesia No: M.HH-01.GR.01.06, on 12 January 2010, citizens from 65 countries are eligible for applying a Visa on Arrival (VOA) This visa can be obtained directly when they arrive at certain airports and seaports in Indonesia, regardless of the purpose of your visit (Business, Tourist, and Social-Cultural).

The general requirements for visa on arrival are:

- The applicant's passport must be valid for at least 6 (six) months from the date of entry.
- VOA may be extended only one time for maximum 30 (thirty) days Round-trip airplane ticket

Fees: Up to 30 (thirty) days: USD 25

VISA BEFORE ARRIVAL

Nationals who are not eligible for free visa or VOA (Visa on arrival) need to make the visa on Indonesian Embassy or Consulate prior to arrival and required an authorization from Indonesian Immigration Head Office Jakarta.

Procedure to get an approval (Calling Visa) from the Indonesia Immigration Head Office Jakarta:

One of the requirements for the Limited Stay Visa is an approval (CALLING VISA) from the Indonesia Immigration Head Office. The request must be submitted by the applicant's sponsor. The following information explains the procedure to get the approval letter.

Procedure

1. Applicant must have a sponsor in Indonesia either a personal, organization or a company
2. Sponsor must present them self in person at the Immigration Head Office in South Jakarta (Jakarta Selatan).
3. The sponsor must have: photocopy of applicant's passport, supporting letter from the sponsor and 3 photographs from the applicant.

The Immigration Head Office Jakarta will send by fax or email the approval to the Indonesian sponsor and also the Embassy.
